CITY RESOLUTION NO. 179-2016

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN AND EXECUTE FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND AMONG THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) REGARDING THE IMPLEMENTATION OF THE SPECIAL LOCAL ROAD FUND UNDER REPUBLIC ACT 8794

WHEREAS, Republic Act No. 8794, otherwise known as the Motor Vehicle User’s Charge Law (MVUC Law), is intended to provide and ensure the adequate maintenance of roads through sufficient funding;

WHEREAS, Section 7 of RA 8794 also provides that “5% of all monies collected shall be deposited in the National Treasury under the Special Local Road Fund which shall be apportioned to provincial and city governments in accordance with vehicle population and size of the road network under their respective jurisdictions and shall be used exclusively for maintenance of local roads, traffic management and road safety devices and for air pollution control”;

WHEREAS, pursuant to Section 3 and Section 5 of Executive Ordinance No. 124, dated January 1987, the Department of Public Works and Highways (DPWH) has decentralized its responsibilities to the fullest extent possible, and may delegate to any agency which it determines to have an adequate technical capability any of its powers and functions consistent with this policy of decentralization. The DPWH is likewise mandated under E.O. 124 to assist the LGUs in developing their capabilities by allowing them greater participation in local maintenance and safety provisions;

WHEREAS, the Department of the Interior and Local Government (DILG) is an agency mandated to exercise general supervision over LGUs and is tasked to strengthen the capability of the LGUs in the delivery of developed services including the maintenance and construction of local roads and to coordinate the activities undertaken by the LGUs;

WHEREAS, the project shall be implemented by Tuguegarao City Government by contract based on the Program of Work prepared by the City Engineering Office and approved by the DPWH;

WHEREAS, Tuguegarao City is a beneficiary of the 2015 Special Local Road Fund with an allotment of Php2,349,945.00 for rehabilitation;

WHEREAS, Tuguegarao-Libag Road and Tuguegarao-Linao-Carig Road sections have been identified and approved for rehabilitation by the Road Board;

WHEREAS, it is necessary that a Memorandum of Agreement should be entered into for the purpose delineating responsibilities over the implementation of policies, standards and procedures at the LGU level in accordance with the pertinent provisions of SLRF under MVUC Law and its Implementing Rules and Regulations;

WHEREAS, this resolution shall only take effect upon the submission of a favorable opinion by the Department of the Interior and Local Government (DILG) stating that in lieu of the inclusion in the Annual Investment Plan of the city, a certification from the City Development Council and a resolution from the Seventh City Council approving the said project will suffice.


NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign and execute for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Public Works and Highways (DPWH) and the Department of the Interior and Local Government (DILG), regarding the implementation of the Special Local Road Fund (SLRF).

RESOLVED FURTHER, that copies of this Resolution be forwarded to the City Mayor, Hon. Atty. Jefferson P. Soriano, Department of Public Works and Highways (DPWH) and Department of the Interior and Local Government (DILG), for their information and appropriate action.

On motion of Hon. Kendrick S. Calubaquib, duly seconded by Hon. Raymund P. Guzman and without any objection, **CITY RESOLUTION NO. 179-2016** was **APPROVED** in plenary under suspended rules on its First, Second and Final Reading.
