RESOLUTION GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, THE AUTHORITY TO SIGN THE MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT WITH THE OVERSEAS WORKERS WELFARE ADMINISTRATION-RW02 TO PUT UP AN OFW MIGRANT DESK IN TUGUEGARAO CITY

WHEREAS, the Overseas Workers Welfare Administration – Regional Welfare Office 2 (OWWA-RW02) is a lead membership welfare institution that serves the interest and welfare of member Overseas Filipino Workers (OFWs);

WHEREAS, the Overseas Workers Welfare Administration – Regional Welfare Office 2 (OWWA-RW02) develops and implements responsive programs and services towards the protection of the interest and promotion of the welfare of its OFWs and recognizes multi-sectoral participation in pursuing and bringing its programs and services closer to its OFW clientele;

WHEREAS, the Overseas Workers Welfare Administration – Regional Welfare Office 2 (OWWA-RW02) intends to set up an OFW MIGRANT DESK in Tuguegarao City with the coordination of the City Government of Tuguegarao represented by the City Mayor, Hon. Atty. Jefferson P. Soriano;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the Memorandum of Agreement (MOA) for perusal and for an authority to enter into the said Memorandum of Agreement;

WHEREAS, after an extensive discussion during the committee meeting held for the said purpose, the Committee on Rules, Laws and Ethics found the terms and conditions in the Memorandum of Agreement to be in order and with merit.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the


