**CITY RESOLUTION NO. 184-2016**

**RESOLUTION GRANTING AUTHORITY TO THE TUGUEGARAO CITY FRANCHISING BOARD TO AUTHORIZE MRS. CORAZON A. CAMAYANG TO APPLY FOR A CHANGE OF UNIT OF HER TRICYCLE FOR HIRE SUBJECT TO COMPLIANCE WITH THE REQUIREMENTS AS PROVIDED IN CITY ORDINANCE NO. 08-2013 AND THE PAYMENT OF REQUISITE FEES**

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the request of Mrs. Corazon A. Camayang for a change of unit of her carnapped tricycle for hire for proper action;

**WHEREAS**, attached to the endorsement is the Tuguegarao City Franchising Board resolution authorizing Mrs. Corazon A. Camayang to apply for a change unit of her tricycle for hire covered by provisional authority to operate tricycle for hire with Case No. 93-1427;

**WHEREAS**, after the joint Committee on Transportation and Committee on Rules, Laws and Ethics deliberated on the matter, the committees found the request to be proper and meritorious considering this was supported by a Police Report and Affidavit of Loss and considering further that the loss of her tricycle is due to force majeure.


