**CITY RESOLUTION NO. 186-2016**

**RESOLUTION GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, THE AUTHORITY TO SIGN THE MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT WITH THE DEPARTMENT OF HEALTH (DOH) R02 FOR THE EXPANSION/IMPROVEMENT OF THE TUGUEGARAO CITY BARANGAY HEALTH SANITATION**

**WHEREAS**, the 16<sup>th</sup> Congress appropriated the amount of Php26,872,368,000.00 under Volume II-B of the Republic Act 10717 known as General Appropriations Act (GAA) of 2016;

**WHEREAS**, the Department of Health (DOH) issued the Guidelines and Procedures on the implementation of the Government Health Facility Upgrading Project under the CY 2016 Health Facilities Enhancement Program;

**WHEREAS**, the objectives of the Government Health Facility Upgrading Project under the CY 2016 Health Facilities Enhancement Program are to ensure the achievement of the health system goals of better health outcomes, sustained health financing and responsive health system ensuring that all Filipinos especially the disadvantaged group in the spirit of solidarity, have equitable access to affordable health care and to improve access to quality hospital and other health care facilities through accelerated upgrading of public health facilities;

**WHEREAS**, the Department of Health (DOH) R02 wanted to enter in a Memorandum of Agreement with the City Government represented by Hon. Atty. Jefferson P. Soriano in his capacity as the City Mayor for the Expansion/Improvement of the Tuguegarao City Barangay Health Sanitation;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the Memorandum of Agreement (MOA) for perusal and for an authority to enter into the said Memorandum of Agreement;

**WHEREAS**, after an extensive discussion during the joint committee meeting held for the said purpose, the Committee on Rules, Laws and Ethics and Committee on Health and Sanitation found the terms and conditions in the Memorandum of Agreement to be in order and with merit.



