**A RESOLUTION APPROVING CDC RESOLUTION NO. 09, SERIES OF 2016 –
 “A RESOLUTION INITIATING THE UPDATE OF THE TUGUEGARAO CITY
 COMPREHENSIVE LAND USE PLAN (CLUP)”**

WHEREAS, Section 20 (c) of Republic Act (RA) 7160, otherwise known as the Local Government Code of 1991, mandates that the “local government units shall, in conformity with existing laws, continue to prepare their respective comprehensive land use plans enacted through zoning ordinances which shall be the primary and dominant bases for the future use of land resources, provided that the requirements for food production, human settlements and industrial expansion shall be taken into consideration in the preparation of such plans;

WHEREAS, the City Development Council (CDC) has approved in their meeting CDC Resolution No. 09, series of 2016 titled “*A Resolution Initiating the Update of the Tuguegarao City Comprehensive Land Use Plan (CLUP)*”;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, through a letter dated October 12, 2016, endorsed CDC Resolution No. 09 to the Seventh City Council for appropriate action;

WHEREAS, after deliberation on the matter during their 14th Regular Session, the Seventh City Council found the urgent need to initiate the updating of the Tuguegarao City Comprehensive Land Use Plan (CLUP).

NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve CDC Resolution No. 09, series of 2016 titled “*A Resolution Initiating the Update of the Tuguegarao City Comprehensive Land Use Plan (CLUP)*”.


