WHEREAS, Section 105 (a) of Republic Act (RA) 7160, otherwise known as the Local Government Code of 1991, mandates that “each local government unit shall have a multi-sectoral development plan to be initiated by its development council and approved by its sanggunian. For this purpose, the development council at the provincial, city, municipal, or barangay level, shall assist the corresponding sanggunian in setting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction;

WHEREAS, the City Development Council has approved in their meeting CDC Resolution No. 10, series of 2016 titled “*A Resolution Initiating the Update of the Tuguegarao City Comprehensive Development Plan (CDP)*”;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, through a letter dated October 12, 2016, endorsed CDC Resolution No. 10 to the Seventh City Council for appropriate action;

WHEREAS, during their 14th Regular Session, the Seventh City Council found the urgent need to initiate the updating of the Tuguegarao City Comprehensive Development Plan (CDP) for the period of CY 2016-2024;


