**CITY RESOLUTION NO. 193-2016**

**RESOLUTION ENDORSING THE APPLICATION FOR AFFILIATION OF  
 TUGUEGARAO CITY LIBRARY WITH THE NATIONAL LIBRARY OF THE PHILIPPINES**

**WHEREAS**, public libraries are essential repositories, not only of our national culture, but also of the culture of other peoples and nations, vital for mental, spiritual, cultural and physical development of the community as it seeks to provide opportunities and encouragement to people of all ages, races and religions and persuasion to educate themselves;

**WHEREAS**, the Tuguegarao City Library was established and inaugurated on the 18<sup>th</sup> day of December 2006 but until now the said library is still not affiliated with the National Library of the Philippines, thereby it cannot avail of the benefits given by the said agency to libraries with affiliation;

**WHEREAS**, the Library was provided the following:

1. Officer in Charge/Municipal Librarian, whose salary is being paid by the Local Government of Tuguegarao City;
2. Sufficient number of chairs, reading tables, bookshelves and other library equipment;
3. Subscription with local periodicals and newspapers;

4. Supplies such as books, cards and other office supplies; and,
5. A signboard identifying it as Tuguegarao City Library.

**WHEREFORE**, the foregoing premises considered, be it **RESOLVED**, as it is hereby **RESOLVED**, by the Sangguniang Panlungsod in session assembled, to endorse, as it hereby endorses the application for affiliation of Tuguegarao City Library with the National Library of the Philippines.

**RESOLVED FURTHER**, that the Secretary to the Sangguniang Panlungsod shall be made secondarily liable to the books and other reading materials allocated by the National Library of the Philippines and the Library Custodian shall be required by the Secretary to the Sangguniang Panlungsod to conduct an annual inventory of the book allocations and a general inventory for clearance purposes prior to his/her retirement, resignation or transfer to another office.

**RESOLVED FURTHERMORE**, that the Library Custodian shall be under the technical supervision of the National Library of the Philippines with respect to his/her duties and functions. Provided that he/she shall be provided funds by the Local Government Unit and given authority to travel to Manila to receive book allocations, confer with library officials and attend seminars and conferences for professional growth and development.


**RESOLVED FURTHERMORE**, that the Local Government of Tuguegarao City shall abide by the present rules and regulations, as well as those that may hereafter be promulgated by the National Library of the Philippines in furtherance of public library service.

**RESOLVED FINALLY**, that copies of this Resolution be forwarded to the Director of the National Library of the Philippines, the City Treasurer, the Library Custodian and the City Mayor, Hon. Atty. Jefferson P. Soriano, for their information and guidance, with the copy for the Director of the National Library of the Philippines accompanied by a certification of the City Treasurer that funds are available for the maintenance of the Library.

On motion of Hon. Arnel T. Arugay, duly seconded by Hon. Raymund P. Guzman and Hon. Grace B. Arago and without any objection, **CITY RESOLUTION NO. 193-2016** was **APPROVED** in plenary under suspended rules.
