CITY RESOLUTION NO. 194-2016

**RESOLUTION DECLARING TUGUEGARAO CITY
 UNDER A STATE OF CALAMITY DUE TO SUPER TYPHOON LAWIN**

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 provides that the Sangguniang Panlungsod shall *“adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events”*;

WHEREAS, Tuguegarao City was placed under signal no. 5 by Philippine Atmospheric Geological and Astronomical Services Administration (PAGASA) on October 19, 2016 due to super typhoon “Lawin”;

WHEREAS, Tuguegarao City was heavily devastated by super typhoon “Lawin”, displacing a number of residents and causing heavy damage to properties;

WHEREAS, the City Disaster Risk Reduction and Management Council (CDRRMC) had an emergency meeting on October 20, 2016 and passed Council Resolution No. 03-2016 – *A Resolution Recommending the City of Tuguegarao Be Declared Under a State of Calamity Due to Damages Caused by Typhoon Lawin*;

WHEREAS, the City Mayor, Hon. Jefferson P. Soriano, requested for the holding of a special session on October 20, 2016 for the declaration of Tuguegarao City under a state of Calamity due to super typhoon “Lawin”;

WHEREAS, the City Social Welfare and Development Officer and the City Agriculturist represented by the City Treasurer have reported on the extent of damage of affected households and on agricultural crops during the said special session.


NOW THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to declare Tuguegarao City under State of Calamity due to super typhoon "Lawin."

RESOLVED FURTHER, that necessary measures be undertaken to facilitate rescue, recovery, relief, rehabilitation and return to productive livelihood of the affected citizenry of Tuguegarao City.
