 OF TUGUEGARAO CITY**

WHEREAS, Tuguegarao City was heavily devastated by Super Typhoon Lawin on October 19, 2016;

WHEREAS, Tuguegarao City experienced total electric blackout due to the damages caused by the said super typhoon which included the collapse of 146 electrical posts;

WHEREAS, for the immediate and speedy electrical power rehabilitation, there is a need to augment the present fund of Cagayan Electric Cooperative (CAGELCO) I.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to urge the National Electrification Authority (NEA) to provide financial assistance to CAGELCO I, for the electrification of Tuguegarao City.

RESOLVED FURTHER, to forward copies of this Resolution to the City Mayor, Hon. Jefferson P. Soriano, for his information and to the National Electrification Authority (NEA), for appropriate action.
