CITY RESOLUTION NO. 197-2016

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR,
 HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE
 TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA)
 WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT,
 REGIONAL OFFICE NO. 2 FOR THE IMPLEMENTATION OF THE
 DOLE EMERGENCY EMPLOYMENT PROGRAM**

WHEREAS, Tuguegarao City was heavily devastated by super typhoon “Lawin”, displacing a number of residents and causing heavy damage to properties;

WHEREAS, the Department of Labor and Employment (DOLE), Regional Office No. 02 has been given the responsibility to implement Emergency Employment Program to enable the victims of natural calamities to engage in short-term community works to provide them with temporary wage employment for a period of 10 days;

WHEREAS, the Local Government Unit (LGU) of Tuguegarao City has been identified as a recipient of the said employment program;

WHEREAS, there is a need for a Memorandum of Agreement (MOA) between the LGU of Tuguegarao City and the DOLE-RO NO. 02 in order to formalize the employment program;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed and requested the Seventh City Council for an authority to sign the said MOA for and on behalf of the City Government;

WHEREAS, after having reviewed the terms and conditions in the MOA, the Seventh City Council found the same to be in order, necessary, favorable and beneficial to the constituents of the City.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement (MOA) with the Department of Labor and Employment (DOLE), Regional Office No. 2 for the implementation of the Emergency Employment Program.

RESOLVED FURTHER, to forward copies of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, and to the Department of Labor and Employment (DOLE), Regional Office No. 2, for their information and appropriate action.
