**CITY RESOLUTION NO. 200-2016**

**RESOLUTION GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, THE AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-ENVIRONMENT MANAGEMENT BUREAU (DENR-EMB) AND SM PRIME HOLDINGS, INC. ON THE CREATION OF THE MULTI-PARTITE MONITORING TEAM, ENVIRONMENTAL MONITORING FUND AND THE ENVIRONMENTAL GUARANTEE FUND**

**WHEREAS**, SM Prime Holdings, Incorporated has been issued an Environmental Compliance Certificate (ECC) with ECC Reference Code No. ECC-R02-1608-0069 on August 23, 2016 pursuant to Presidential Decree No. 1586 for its proposed SM City Tuguegarao located at Barangay Caritan Norte, Tuguegarao City, Cagayan;

**WHEREAS**, the Environmental Compliance Certificate (ECC) requires the formation of a Multi-Partite Monitoring Team and shall be composed of representatives from the Department of Environment and Natural Resources (DENR), the SM Prime Holdings, Inc., the LGU of Tuguegarao City, Barangays of Caritan Norte, Caritan Centro, Bagay, Atulayan Sur and San Gabriel, Philippine Chamber of Commerce and Industry Cagayan Chapter, Caritan Norte Elementary School, Cagayan State University and St. Peter Metropolitan Cathedral Parish;

**WHEREAS**, the Environmental Compliance Certificate (ECC) requires the establishment of an Environmental Guarantee Fund as a fund source for the indemnification of damages caused by SM Prime Holdings, Inc. and immediate rehabilitation and/or restoration of affected ecosystems, and Environmental Monitoring Fund to cover the expenses of environmental monitoring and surveillance activities;

**WHEREAS**, the LGU of Tuguegarao City is one of the representatives in the formation of a Multi-Partite Monitoring Team;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, shall be the representative of the LGU-Tuguegarao in the formation of a Multi-Partite Monitoring Team;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the Memorandum of Agreement (MOA) for perusal and for an authority to enter into the said Memorandum of Agreement;

**WHEREAS**, after an extensive discussion during the joint committee meeting held for the said purpose, the Committee on Rules, Laws and Ethics and the Committee on Climate Change, Environmental Protection and Ecology found the terms and conditions in the Memorandum of Agreement to be in order and with merit.


**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Environment and Natural Resources-Environment Management Bureau (DENR-EMB) and SM Prime Holdings, Inc. on the creation of the Multi-Partite Monitoring Team, Environmental Monitoring Fund and the Environmental Guarantee Fund.

**RESOLVED FURTHER**, to forward a copy of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, for his information and appropriate action and to Department of Environment and Natural Resources-Environment Management Bureau (DENR-EMB) and SM Prime Holding, Inc., for their information and guidance.
