CITY RESOLUTION NO. 201-2016

RESOLUTION ACCREDITING ZONTA CLUB OF CENTRAL TUGUEGARAO AND PHILIPPINE FOUNDATION OF THE BROTHERHOOD OF CHRISTIAN BUSINESSMEN AND PROFESSIONALS, INC. AS CIVIL SOCIETY ORGANIZATIONS BASED IN TUGUEGARAO CITY PURSUANT TO DILG MC NO. 2016-97

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular (MC) 2016-97 “Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies” dated July 19, 2016;

WHEREAS, the said Memorandum of Agreement reiterates the provisions of the Local Government Code relative to the accreditation of civil society organizations and in the selection of representatives to the local special bodies to strengthen their participation in local governance and development processes;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City recognizes the vital role of Civil Society Organizations (CSOs) which include non-stock and non-profit associations, non-governmental organizations, people’s organizations, civil organizations, cooperatives, social movements and professional and business groups in nation building and their collective efforts towards progress;

WHEREASM the Sangguniang Panlungsod of Tuguegarao City further recognizes the role of the CSOs as partners of the Tuguegarao City Government not only in policy and planning formulation but more so in development implementation;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City through the Committee on Rules, Laws and Ethics has reviewed and approved the application for accreditation of Zonta Club of Central Tuguegarao having complied with the documentary requirements:

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City through the Committee on Rules, Laws and Ethics has reviewed and approved, too, the application for accreditation of Philippine

Foundation of the Brotherhood of Christian Businessmen and Professionals, Inc. pending submission of their lacking documents to the Office of the Secretariat of this City within thirty (30) days from receipt of Notice to comply with the deficiencies;

WHEREAS, the accreditation shall be valid for three (3) years commencing upon approval of this resolution up to June 2019;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City reserves the right to revoke and/or cancel the accreditation in the event that they fail to comply with their undertakings or for any violation of existing laws, rules and regulations.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to accredit Zonta Club of Central Tuguegarao and Philippine Foundation of the Brotherhood of Christian Businessmen and Professionals, Inc. as Civil Society Organizations based in Tuguegarao City pursuant to DILG MC No. 2016-97 to entitle them with prerogatives and privileges stated therein.

RESOLVED FURTHER, to forward copies of this Resolution to Zonta Club of Central Tuguegarao and to the Philippine Foundation of the Brotherhood of Christian Businessmen and Professionals, Inc., for their information.
