## **CITY RESOLUTION NO. 202-2016**

# A RESOLUTION GRANTING FINANCIAL ASSISTANCE WITH THE MINIMUM AMOUNT OF FIVE THOUSAND PESOS (P5,000.00) TO ALL OFFICIALS AND EMPLOYEES INCLUDING CASUALS AND JOB ORDERS OF THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 provides that the Sangguniang Panlungsod shall "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events";


WHEREAS, Tuguegarao City was placed under signal number 5 by the Philippine Atmospheric Geological and Astronomical Services Administration (PAGASA) on October 19, 2016 due to super typhoon "Lawin";

WHEREAS, Tuguegarao City was heavily devastated by super typhoon "Lawin", displacing a number of residents and causing heavy damage to properties;

WHEREAS, the employees of the Local Government Unit of Tuguegarao City were not spared from the devastating effects of the said super typhoon since a number of them had houses and properties completely or partially damaged;

WHEREAS, during its 16<sup>th</sup> Regular Session, the Seventh City Council found it necessary and timely to grant financial assistance with the minimum amount of Five Thousand Pesos (P5,000.00) to all LGU employees.

NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant financial assistance with the minimum amount of Five Thousand Pesos (P5,000,00) to all officials and employees including



casuals and job orders of the Local Government of Tuguegarao City subject to the availability of funds, enactment of an appropriation ordinance and the usual accounting and auditing rules and regulations.

**RESOLVED FURTHER**, to forward a copy of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, for his information and appropriate action.
