A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY.

JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY
GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL
LIBRARY FOR THE AFFILIATION OF THE CITY LIBRARY

WHEREAS, Tuguegarao City has created and established a local library in accordance with the Local Government Code and Republic Act 7743, An Act Providing for the Establishment of Congressional, City and Municipal Libraries and Barangay Reading Centers throughout the Philippines;

WHEREAS, the City Library is manned by the Local Government Unit of Tuguegarao through its Library employees;

WHEREAS, in order for the City Library to be able to receive updated materials from the National Library, affiliation with it is needed;

WHEREAS, as mandated by law, the National Library is tasked in undertaking the affiliation of Local Libraries through the execution of a Memorandum of Agreement (MOA);

WHEREAS, the City Mayor. Hon. Atty. Jefferson P. Soriano, has endorsed and requested to the Seventh City Council for an authority to sign the said MOA for and on behalf of the Tuguegarao City Government;

WHEREAS, after having reviewed the terms and conditions of the MOA, the Seventh City Council found the same to be in order, necessary and beneficial.

NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement (MOA) with the National Library for the affiliation of the City Library.
