CITY RESOLUTION NO. 213-2016

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION (POEA)

WHEREAS, Republic Act No. 8042, as amended by Republic Act No. 10022, mandates local government units, in partnership with the concerned government agencies, to take a proactive stance in disseminating information to their constituents in all aspects of overseas employment;

WHEREAS, the convergence of programs of different agencies of DOLE pursuant to Administrative Order No. 157, Series of 2013, is a strategy to enhance the empowerment and protection of public and migrant workers and to optimize the limited resources of government;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the Memorandum of Agreement (MOA) for perusal and requested for an authority to sign the Memorandum of Agreement for and on behalf of the Tuguegarao City Government with the Philippine Overseas Employment Administration (POEA);

WHEREAS, after an extensive discussion during the joint committee meeting held for the said purpose, the Committee on Rules, Laws and Ethics and Committee on Human Resources and Development found the terms and conditions in the Memorandum of Agreement to be in order and with merit.


