WHEREAS, the Committee on Appropriations reviewed the Supplemental Budget No. 01 of Barangay Cataggaman Viejo for CY 2016;




On motion of Hon. Danilo L. Baccay and without any objection, **CITY RESOLUTION NO. 215-2016** was **APPROVED** in plenary.
