CITY RESOLUTION NO. 219-2016

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT TO SIGN AND ENTER INTO AN IMPLEMENTATION MANAGEMENT AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE (DA) AND ENTERPRISE AGREEMENTS WITH PROPONENT GROUPS IN INFRASTRUCTURE DEVELOPMENT, ENTERPRISE DEVELOPMENT WITH CIVIL WORKS AND ENTERPRISE DEVELOPMENT

WHEREAS, the Philippine Rural Development Project (PRDP) is a poverty reduction and agriculture and fisheries project development program of the Department of Agriculture (DA) that aims to increase rural incomes and enhance farm and fishery productivity in the targeted areas in the Philippines;

WHEREAS, the Local Government Unit (LGU) of Tuguegarao City Government has manifested its interest to participate in the said project and forwarded to the DA the documentary requirements for its proposed sub-projects involving agri-fishery development in consonance with the Agriculture and Fisheries Modernization Plan (AFMP);

WHEREAS, in order to ensure the successful implementation of the sub-projects and achieve the projects' desired objectives, there is a need for the Local Government Unit (LGU) of Tuguegarao City to enter into an Implementation Management Agreement with DA and Enterprise Agreements with proponent groups;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Seventh City Council to grant him an authority to sign for and on behalf of the Tuguegarao City Government the Implementation Management Agreement with DA and Enterprise Agreements with proponent groups for the said undertakings;



WHEREAS, after a thorough deliberation, the Committee on Agriculture and Committee on Infrastructure and Public Utilities found the request to be in order and beneficial to LGU Tuguegarao City and to its constituents.


