RESOLUTION APPROVING THE CONTRACT OF SERVICE AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE CONTRACT OF SERVICE WITH DR. REYMUNDO BLANCAFLOR, AN ANAESTHESIOLOGIST FOR TUGUEGARAO CITY PEOPLE'S GENERAL HOSPITAL

WHEREAS, Tuguegarao City Government operates the Tuguegarao City People's General Hospital (TCPGH), which is a first level, 68-bed capacity hospital;

WHEREAS, the TCPGH has no licensed Anaesthesiologist employed;

WHEREAS, there is a need for the services of an Anaesthesiologist as required by the Department of Health in order for the TCPGH be granted a license to operate;

WHEREAS, Dr. Reymundo Blancaflor is a duly licensed Anaesthesiologist, well trained private practitioner with sufficient experience and skill in Anaesthesiology;

WHEREAS, Dr. Blancaflor offered his professional services as Anaesthesiologist to the TCPGH on a contractual basis.

RESOLVE, as it is hereby **RESOLVED**, to approve the Contract of Service between the Tuguegarao City Government and Dr. Reymundo Blancaflor and grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Contract of Service with Dr. Reymundo Blancaflor.
