CITY RESOLUTION NO. 236-2016

A RESOLUTION REQUESTING THE NATIONAL MEAT INSPECTION SERVICE (NMIS) TO EXTEND FINANCIAL ASSISTANCE TO THE LOCAL GOVERNMENT UNIT (LGU) OF TUGUEGARAO CITY FOR THE UPGRADING OF THE TUGUEGARAO CITY SLAUGHTERHOUSE ON A COUNTER-PARTING BASIS

WHEREAS, Republic Act (RA) 9296, otherwise known as the Meat Inspection Code of the Philippines, provides that Local Government Units (LGUs) shall endeavor to improve existing meat facilities to comply with the national standards, and the national government shall allocate funds as incentive, equivalent to the funds available from LGUs for this purpose;

WHEREAS, the Meat Establishment Improvement Program (MEIP) is designed to assist LGUs to rehabilitate and/or complete their existing slaughterhouses and poultry dressing plants to comply with Class "AA" requirements under National Meat Inspection Service (NMIS) accreditation system;

WHEREAS, LGU Tuguegarao City is a qualified beneficiary of the said Meat Establishment Improvement Program (MEIP) for Calendar Year 2017;

WHEREAS, one of the requirements to avail of the said financial assistance is a resolution from the present Sanggunian requesting the NMIS for the same purpose as per letter of NMIS to City Mayor, Hon. Atty. Jefferson P. Soriano.


NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to request the National Meat Inspection Service (NMIS) to extend financial assistance to the Local Government Unit of Tuguegarao City for the upgrading of the Tuguegarao City Slaughterhouse on a counter-parting basis.

RESOLVED FURTHER, to forward copies of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, and to the Department of Agriculture-National Meat Inspection Service.
