**A RESOLUTION APPROVING CITY DEVELOPMENT COUNCIL RESOLUTION NO. 15-2015
“RESOLUTION ENDORSING TO THE 7TH TUGUEGARAO CITY COUNCIL THE APPROVAL OF
THE TUGUEGARAO CITY CY 2008, 2009, 2010 AND 2013 EXCISE TAX UTILIZATION”**

WHEREAS, Tuguegarao City is granted a share in the amount of Twenty Million Six Hundred Twenty Two Thousand One Hundred Ninety Seven Pesos (P20,622,197.00), a share on the collection of Burley and Native Tobacco Excise Tax against the FYs 2008, 2009, 2010 and 2013 pursuant to Local Budget Memorandum No. 73, dated March 8, 2016;

WHEREAS, the Tuguegarao City Development Council has passed CDC Resolution No. 15-2016, endorsing the Excise Tax Utilization for CYs 2008, 2009, 2010 and 2013;

WHEREAS, the said CDC Resolution enumerates the different programs and projects to be undertaken which shall be funded from the share of Tuguegarao City in the collection of Burley and Native Tobacco Excise Tax for CYs 2008, 2009, 2010 and 2013, to wit:

Remaining Shares of Cities and Municipalities from the Prior Years' Collections of Excise Taxes Chargeable against the FYs 2010-2013 General Appropriations Act.

NOW, THEREFORE, for and in consideration of the foregoing premises, **RESOLVED**, that CDC Resolution No. 15-2016 endorsing the approval of CYs 2008, 2009, 2010 and 2013 Excise Tax Utilization granted to Tuguegarao City as its share from the CYs 2008, 2009, 2010 and 2013 collection of Burley and Native Tobacco Excise Tax in the amount of P20,622,197.00 be approved.


