**A RESOLUTION REQUESTING FUND ASSISTANCE FROM SECRETARY
 EMMANUEL E. PINOL OF THE DEPARTMENT OF AGRICULTURE
 FOR THE FARM-TO-MARKET ROADS OF THE RURAL BARANGAYS
 OF TUGUEGARAO CITY**

WHEREAS, for an effective and efficient delivery of basic services and facilities to the constituents, the Local Government Code of 1991 has devolved to local government units specific functions and responsibilities to attain good governance;

WHEREAS, Tuguegarao City was placed under signal no. 5 by the Philippine Atmospheric Geological and Astronomical Services Administration (PAGASA) on October 19, 2016 due to super typhoon "Lawin";

WHEREAS, Tuguegarao City and its rural barangays were heavily devastated by super typhoon "Lawin";

WHEREAS, the immediate need of these rural barangays is farm-to-market roads for easy and immediate transport of their agricultural products;

WHEREAS, the City Mayor, Hon. Jefferson P. Soriano, has endorsed to the Seventh City Council the request letter to Secretary Emmanuel E. Pinol of the Department of Agriculture for a fund assistance for farm-to-market roads;

WHEREAS, after a deliberation, the Seventh City Council found the request to be in order and beneficial to the constituents of the city.


