**CITY RESOLUTION NO. 263-2016**

**A RESOLUTION URGING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO PROVIDE A PARKING SPACE FOR PERSONS WITH DISABILITIES (PWDs) FOR ALL BUILDING STRUCTURES OWNED BY THE CITY GOVERNMENT PURSUANT TO BATAS PAMBANSA 344 AND ITS IMPLEMENTING RULES AND REGULATIONS**

**WHEREAS**, Section 11, Article XIII of the 1987 Constitution declares that “the state shall prioritize for the needs of the under privileged, sick, elderly, disabled, women and children;”

**WHEREAS**, Batas Pambansa (BP) Bilang 344, otherwise known as an “Act to Enhance the Mobility of Disabled Persons by Requiring Certain Buildings, Institutions, Establishments and Public Utilities to Install Facilities and Other Devices”, with its Implementing Rules and Regulations (IRR) was enacted primarily for the welfare of Persons with Disabilities;

**WHEREAS**, Rule 2 (1.3) of the Implementing Rules and Regulations (IRR) of BP 344 includes the Basic Physical Planning Requirements which are Accessibility, Reachability, Usability, Orientation, Safety and Work Ability and Efficiency;

**WHEREAS**, Rule 3 of the said Implementing Rules and Regulations, on the other hand, provides that “accessible parking spaces with signages shall be located as near as possible to ingress/egress spaces of the building or structure;”

**WHEREAS**, Section 458 (5) paragraph (xiv) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides for the care of disabled persons, paupers, the aged, the sick persons of unsound mind, abandoned minors and juvenile delinquents.

**NOW THEREFORE**, in consideration of the foregoing premises, be it


**RESOLVE**, as it is hereby **RESOLVED**, to ordain Tuguegarao City Government to provide a parking space for Persons with Disabilities (PWDs) for all buildings structures owned by the City Government pursuant to the provision of Batas Pambansa 344 and its Implementing Rules and Regulations.

**RESOLVED FURTHER**, to forward copies of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, the City Social Welfare and Development Office, the General Services Office and the City Engineering Office, for their information, guidance and appropriate action.
