CITY RESOLUTION NO. 264-2016

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF CAGAYAN FOR THE CONCRETING OF DUPAYA STREET AT BARANGAY LEONARDA, TUGUEGARAO CITY AMOUNTING TO P1,000,000.00

WHEREAS, Section 333 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that Local Government Units may group themselves, consolidate or coordinate their efforts, services and resources for purposes commonly beneficial to them;

WHEREAS, the Provincial Government of Cagayan through its Annual Investment Program for CY 2016 has identified Tuguegarao City as one of the recipients of the financial assistance amounting to One Million Pesos (P1,000,000.00) for the concreting of Dupaya Street at Barangay Leonarda, Tuguegarao City;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested from the Seventh City Council, through his letter dated November 23, 2016, for an authority to sign the Memorandum of Agreement with the Provincial Government of Cagayan;

WHEREAS, the Committee on Infrastructure and Public Utilities during the committee meeting held for the said purpose found the Memorandum of Agreement to be in order, meritorious and beneficial to the constituents of Tuguegarao City.


NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Provincial Government of Cagayan for the concreting of the Dupaya Street at Barangay Leonarda, Tuguegarao City amounting to One Million Pesos (P1,000,000.00).
