**CITY RESOLUTION NO. 272-2016**

**RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST) RO2 IN THE IMPLEMENTATION OF “DEPLOYMENT OF EARLY WARNING SYSTEMS IN DISASTER-PRONE AREAS”**

**WHEREAS**, the Department of Science and Technology (DOST) RO2 has been assisting the local government units and other government offices through various science-based programs and projects in recognition of their contribution to regional development;

**WHEREAS**, the DOST RO2 has collaborated with the Advanced Science and Technology Institute (ASTI) and the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) in the implementation of the project titled “Deployment of Early Warning Systems in Disaster-prone Areas”;

**WHEREAS**, the DOST RO2 has identified the critical need to support the establishment and operation of devices and related facilities in order to obtain updated and factual time weather situation prevailing in the city and to give early warning to the communities;

**WHEREAS**, the LGU-Tuguegarao City is committed in hosting the installation and operation of early warning device particularly three (3) units of Sirens;

**WHEREAS**, the DOST and LGU-Tuguegarao City pledge to extend their full cooperation in the effective and efficient implementation of the aforesaid project.


**NOW, THEREFORE, RESOLVED**, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Science and Technology (DOST) RC2 in the implementation of “Deployment of Early Warning Systems in Disaster-prone Areas”.
