**CITY RESOLUTION NO. 275-2016**

**RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO NEGOTIATE WITH INTERESTED PRIVATE CORPORATIONS OR INDIVIDUALS FOR THE MAINTENANCE AND OPERATION OF THE PARKING LOT OF THE TUGUEGARAO CITY CENTRAL PUBLIC MARKET**

**WHEREAS**, Section 22 (c) of Republic Act 7160, otherwise known as the Local Government Code, grants the power to the *Local Chief Executive to enter into contracts or behalf of the local government unit with prior authorization by the Sanggunian concerned*;

**WHEREAS**, the City Government of Tuguegarao is the administrator of the Tuguegarao City Central Public Market with a parking lot located at its basement;

**WHEREAS**, various complaints were raised due to disorderly parking system in the parking space;

**WHEREAS**, in order to maintain an orderly and systematic operation of the said parking space, it is deemed more appropriate and advantageous to the City Government of Tuguegarao to let interested private corporations or individuals maintain and operate the same, and to form a monitoring Body for this purpose;

**WHEREAS**, to require the qualified operator to apply for a cash bond.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to negotiate with interested private corporations or individuals for the maintenance and operation of the parking lot of the Tuguegarao City Central Public Market.

**RESOLVED FURTHER**, that the Memorandum of Agreement be subject for approval by the Sangguniang Panlungsod.

**RESOLVED FINALLY**, to forward copies of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, and to the Market Administrator, Mr. Rodolfo A. Brillantes, for their information.
