CITY RESOLUTION NO. 276-2016

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO NEGOTIATE WITH THE DEPARTMENT OF HEALTH RO2 FOR THE IMPLEMENTATION OF WATER AND SANITATION PROJECTS UNDER THE BOTTOM-UP BUDGETING FOR FY 2016

WHEREAS, Executive Order 102 mandates the Department of Health to provide assistance to Local Government Units (LGUs), people's organization and other members of civil society in implementing health programs, projects and services that will promote the health and well-being of every Filipino; prevent and control diseases among population at risks; protect individual families and communities exposed to hazards and risk that could affect their health; and treat, manage and rehabilitate individuals affected by diseases and disability;

WHEREAS, Bottom-up Budgeting Process, an approach to preparing budget proposals of agencies, taking into consideration the development needs of poor cities/municipalities as identified in their respective Local Poverty Reduction Action Plans (LPRAP), shall be formulated with the strong participation of basic sector organizations and other civil society organizations shall be adopted to be able to fasttrack the achievement of the Millennium Development Goals of reducing poverty;

WHEREAS, the Department of Health through the Office of the Secretary issued Department Order No. 2016-0036 dated February 11, 2016: Guidelines of the Sub-allotment and Utilization of Funds for Regional Offices for the Implementation of Water and Sanitation Projects under Bottom-up Budgeting (BuB) FY 2016;

WHEREAS, included in the lists of funded Bottom-up Budgeting (BuB) Regular Monthly Sampling of Water Sources Project is the amount of Five Hundred Thousand Pesos (P500,000.00) allocated to the Local Government Unit of Tuguegarao City for its Water and Sanitation Projects;

WHEREAS, the Local Government Unit of Tuguegarao City is willing to assist the First Party in the implementation of the project;

WHEREAS, the Local Government Unit of Tuguegarao City has the capacity and the capability to implement the said project by administration;

WHEREAS, the Local Government Unit of Tuguegarao City has submitted their previous liquidation report of the transferred expenditures and was cleared of financial obligations.




