

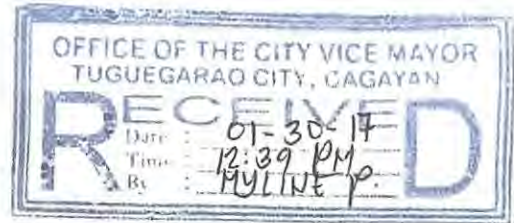



CITY ORDINANCE NO. 02-2017

AN ORDINANCE AMENDING SECTION 6 OF CITY ORDINANCE NO. 01-2017 “AN ORDINANCE SUSPENDING ALL EXISTING TRAFFIC ORDINANCES AND OTHER RELATED ORDINANCES AND ADOPTING A NEW EXPERIMENTAL TRAFFIC SCHEME WITHIN THE TERRITORIAL JURISDICTION OF TUGUEGARAO CITY FOR A PERIOD OF SIXTY (60) DAYS STARTING ON JANUARY 06, 2017 TO MARCH 06, 2017”

RESOLVED, as it is hereby **RESOLVED**, to amend Section 6 of City Ordinance No. 01-2017, to wit:


SECTION 6. TRUCK AND PUBLIC UTILITY VEHICLES BAN.

1. NO ENTRY for all heavy vehicles with gross weight of 4,500 kilograms and above in all streets within the Poblacion from 6 o'clock in the morning to 9 o'clock in the evening;
2. Vehicles and other heavy equipment used in government projects including firetrucks and ambulances and in ongoing constructions within the poblacion are exempted from the truck/vehicle ban; and,
3. **Public Utility Vehicles such as Public Utility Vans (PUVs), Public Utility Buses (PUBs) and Public Utility Jeepneys (PUJs) are prohibited to enter the Poblacion (Centro 01-12) including Ugac Sur, Ugac Norte, part of Caritan Centro and San Gabriel.**

On motion of Hon. Danilo L. Baccay, with eleven (11) members present voting in favor and two (2) against, **CITY ORDINANCE NO. 02-2017** was **APPROVED** in plenary under suspended rules.


