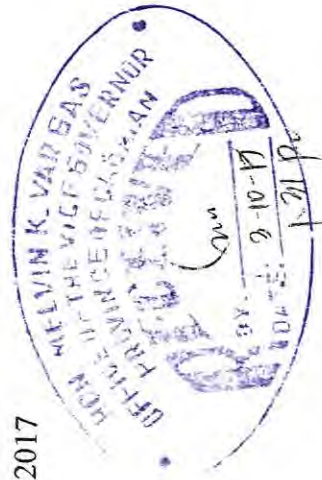

CITY ORDINANCE NO. 05-2017

**AN ORDINANCE AMENDING CITY ORDINANCE NO. 01-2017 AND CITY
 ORDINANCE 02-2017 EXTENDING THE EXISTING EXPERIMENTAL
 TRAFFIC SCHEME TO APRIL 12, 2017**

WHEREAS, all traffic ordinances and other related ordinances were suspended and a new Experimental Traffic Scheme was adopted for a period of sixty (60) days from January 06, 2017 to March 06, 2016 by virtue of City Ordinance No. 01-2017;

WHEREAS, the City Mayor, through his letter dated March 06, 2017, requested for the amendment of City Ordinance No. 01-2017 and City Ordinance No. 02-2017 to extend the period of the Experimental Traffic Scheme to March 31, 2017;

WHEREAS, during their 30th Regular Session held on March 06, 2017, the Seventh City Council discussed and deliberated on the matter and decided to extend the Experimental Traffic Scheme to April 12, 2017;

WHEREAS, the extension of period shall provide more time for review and evaluation of the effectivity of the Experimental Traffic Scheme;

WHEREAS, the said extension of period shall be the last and final extension of the said Experimental Traffic Scheme.

NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to amend City Ordinance No. 01-2017 and City Ordinance No. 02-2017 extending the existing Experimental Traffic Scheme, to wit:

SECTION 10. EFFECTIVITY. This Ordinance will be valid until April 12, 2017.

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Arnel T. Arugay and without any objection, **CITY ORDINANCE NO. 05-2017** was **APPROVED** under suspended rules.
