

CITY ORDINANCE NO. 08-2017

AN ORDINANCE GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA) WITH THE FORTY-NINE (49) COMPONENT BARANGAYS OF TUGUEGARAO CITY FOR THE GRANT OF FINANCIAL ASSISTANCE IN THE IMPLEMENTATION OF BARANGAY PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) FOR THE YEAR 2017

WHEREAS, the Tuguegarao City Government recognizes the capacity of the barangay as a small autonomous governmental unit to implement the developmental projects within its territorial jurisdiction in the promotion of the general welfare of its constituents;

WHEREAS, the Tuguegarao City Government is aware of the limited financial and other resources of every barangay in the realization of its desired Programs, Projects and Activities (PPAs);

WHEREAS, the Tuguegarao City Government, in its desire to help the barangays attain their objectives in uplifting the welfare of their constituents and in the promotion of general welfare, finds it necessary to extend financial assistance to the forty-nine (49) barangays under the conditions herein stated.

NOW, THEREFORE, be it ordained by the Seventh City Council in session assembled to enact:

SECTION 1. TITLE. This ordinance shall be known as “An Ordinance Granting Authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to Sign for and on Behalf of the Tuguegarao City Government the Memorandum of Agreement (MOA) with the Forty-Nine (49) Component Barangays of Tuguegarao City for the Grant of Financial Assistance in the Implementation of Barangay Programs, Projects and Activities (PPAs) for the Year 2017.

SECTION 2. PURPOSE/OBJECTIVE. The purpose of this ordinance is to establish a system in the grant of financial assistance to the forty-nine (49) component barangays of Tuguegarao City.

SECTION 3. SCOPE. This ordinance shall govern the availment of the grant of financial assistance to the forty-nine (49) component barangays of Tuguegarao City for year 2017.

SECTION 4. AUTHORITY. This ordinance is in pursuant to the Commission on Audit Circular No. 2012-001 dated June 14, 2012 as reiterated in Circular No. 2016-002 dated May 31, 2016 requiring the need for a Memorandum of Agreement (MOA) between the Tuguegarao City Government and the recipient barangays and the authority to be given to the City Mayor should be by way of an ordinance and not just a mere resolution .

SECTION 5. QUALIFICATION. The forty-nine (49) component barangays without any disallowance from the Commission on Audit (COA) and who shall be able to comply with the conditions stated herein shall be qualified to avail of the financial assistance.

SECTION 6. APPROPRIATION/FUNDING. The funding of the financial assistance for the forty-nine (49) component barangays shall be appropriated and authorized in the Annual Budget or Supplemental Budget.

SECTION 7. DOCUMENTARY REQUIREMENTS. Since the financial assistance partakes the nature of Fund Transfer, the following documentary requirements should be submitted by the recipient barangay:

- 7.1. Copy of a duly signed Memorandum of Agreement (MOA)
- 7.2. Approved Project Expenditures and Estimated Expenses
- 7.3. A Certification from the City Accountant that the fund previously availed of has been liquidated

SECTION 8. CONDITIONS/REQUISITIES FOR THE GRANT. The following shall be observed as conditions sine qua non for every barangay to be granted the financial assistance:

- 8.1. Duly approved corresponding Program of Work for the PPAs covered by the Memorandum of Agreement (MOA)
- 8.2. Barangay Resolution for the request of financial assistance
- 8.3. Liquidation of the availed financial assistance of the recipient barangay within a period of thirty (30) days upon the completion of the PPAs duly signed and received by concerned individuals and authorities
- 8.4. The use and disbursement of funds shall be subject to the usual accounting and auditing guidelines
- 8.5. Any unused funds after the liquidation and completion of PPAs shall be returned to the City Government

SECTION 9. SEPARABILITY CLAUSE. If any provisions of this ordinance shall be unconstitutional or invalid for whatever reasons, other parts or provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 10. REPEALING CLAUSE. All ordinance and other enacted city legislative measures in connection herewith which are inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.


SECTION 11. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon its approval.

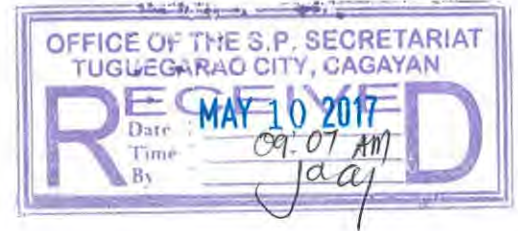
