**CITY ORDINANCE NO. 22-2017**

**ORDINANCE AMENDING SECTION 3, SUB-SECTION 1.2, (b)(1) (A)(2)(d)  
 OF APPROPRIATION ORDINANCE NO. 01-2015 AUTHORIZING THE  
 CY 2015 ANNUAL BUDGET OF TUGUEGARAO CITY**

**WHEREAS**, DBM-DILG-DSWD-NAPC Joint Memorandum Circular No. 7 mandates the Local Poverty Reduction Action Team (LPRAT) to spearhead the formulation and monitoring of Local Poverty Reduction Action Plan (LPRAP);

**WHEREAS**, the purpose of “*One Barangay, One Livelihood*” (OBOL) program is to create souvenir products for Tuguegarao City which are readily available in the local market catering to local and tourist consumers. The establishment of Pasalubong Center is also an avenue to increase the production and income of business sectors in the city;

**WHEREAS**, the requested counterpart of the LGU for BuB CY 2015 OBOL and the downloaded fund from the Department of Trade and Industry were originally charged to Maintenance and Other Operating Expenses (MOOE);

**WHEREAS**, there is a need to change the class expense for the LGU Counterpart from Maintenance and Other Operating Expenses (MOOE) to Capital Outlay (CO) of OBOL-BuB under CY 2015 Annual Budget because the fund was intended for the fabrication of the Pasalubong Center at Mall of the Valley;

**WHEREAS**, the Provincial Director of the Department of Trade and Industry, Dir. Bernardino G. Maborang, has written the City Mayor informing that it is within the prerogative of the LGU to make changes with respect to its counterpart in BuB projects.

**NOW, THEREFORE**, be it ordained by the Seventh City Council in session assembled, to enact “*Ordinance Amending Section 3, Sub-Section 1.2, (b)(1) (A)(2)(d) of Appropriation Ordinance No. 01-2015 Authorizing the CY 2015 Annual Budget of Tuguegarao City.*”

**SECTION 2. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.


