ORDINANCE CREATING THE DIFFERENT POSITIONS UNDER THE OFFICE OF TUGUEGARAO CITY PEOPLE’S GENERAL HOSPITAL, TUGUEGARAO CITY TREASURER’S OFFICE, HUMAN RESOURCES AND MANAGEMENT OFFICE, CITY VICE MAYOR’S OFFICE AND THE TRICYCLE REGULATION UNIT AND PROVIDING FUNDS THEREOF

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the local government units to design and implement their own organizational structure and staffing pattern which will effectively address their respective development plans, programs, objective and priorities;

WHEREAS, the creation of the different positions will contribute efficiency in the delivery of basic services particularly those which have to do with the programs and projects related to the services of the above-mentioned offices;

WHEREAS, in order to promote bureaucratic efficiency by having an effective personnel force, there is a need for the City Government to create the above-mentioned positions and to provide funds thereof.

NOW, THEREFORE, be it ordained by the Seventh City Council in session assembled, to enact “Ordinance Creating the Different Positions Under the Office of Tuguegarao City People’s General

Hospital, Treasurer's Office, Human Resource and Management Office, City Vice Mayor's Office and the Tricycle Regulation Unit and Providing Funds Thereof.

SECTION 1. Creation of New Positions. For purposes of this Ordinance, there is hereby created the following positions, to wit:

1. For the Tuguegarao City People's General Hospital
 - a. One (1) Medical Technologist III – Salary Grade 18
 - b. Two (2) Medical Technologist II – Salary Grade 15
 - c. Two (2) Radiologic Technologist I – Salary Grade 11
 - d. One (1) Pharmacist I – Salary Grade 11
 - e. One (1) Computer Programmer I – Salary Grade 11
2. For the City Treasurer's Office
 - a. One (1) Bookbinder II – Salary Grade 4
 - b. Two (2) Messengers – Salary Grade 2
3. For the HRMO under the Office of the City Mayor
 - a. One (1) Computer Operator IV – Salary Grade 14
4. For the Office of the City Vice Mayor
 - a. Two (2) Senior Administrative Assistant II (Computer Operator IV) – Salary Grade 14
5. For the Tricycle Regulation Unit
 - a. Two (2) Computer Operator IV – Salary Grade 14
 - b. One (1) Bookbinder I – Salary Grade 2

SECTION 2. Funding. The funds necessary for the salary, benefits and other emoluments of the above-stated positions shall be appropriated in the Annual Budget and in any Supplemental Budget of Tuguegarao City subject to Personal Services Limitations as provided by Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

SECTION 3. Qualifications. All matters pertinent to recruitment and placement for the above created positions shall be governed by Civil Service Laws, Rules and Regulations, and such other related issuances.

Section 4. Effectivity. This Ordinance shall take effect immediately upon approval.
