CITY ORDINANCE NO. 31-2017

AN ORDINANCE NAMING THE CITY ROAD FROM THE END OF BATANG STREET, CAGGAY TO THE ROAD OPPOSITE OF OR BEFORE LAMUD STREET, CATAGGAMAN NUEVO AS *PINACANAUAN NA TUGUEGARAO AVENUE*

WHEREAS, Paragraph c, Section 13 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, confers the power to the Sangguniang Panlungsod, in consultation with the Philippine Historical Commission, to name or change the name of its roads, avenues, boulevards thoroughfares and bridges within its territorial jurisdiction;

WHEREAS, Administrative Order No. 2013-06 dated 24 January 2013 of the Department of Environment and Natural Resources (DENR) designated *Pinacanauan de Tuguegarao* as Water Quality Management Area (WQMA) because of its critical importance to Tuguegarao City and to other municipalities in the Province of Cagayan. The declaration recognizes *Pinacanauan de Tuguegarao* as sustaining resource for the people of Tuguegarao City;

WHEREAS, the *Pinacanauan de Tuguegarao River* is a natural landmark which gives the city its aesthetic beauty, biodiversity and balanced ecology, and provides life support system to the people;

WHEREAS, the *Pinacanauan de Tuguegarao River* is an important part of the City's geography and identity that separates eastern barangays from the other barangays;

WHEREAS, Tuguegarao City Government intends to name the city road from the end of Batang Street, Caggay to the road opposite of or before Lamud Street, Cataggaman Nuevo commonly known as Teresita Boulevard to be named as *Pinacanauan Na Tuguegarao Avenue*;

WHEREAS, the city road is located along the *Pinacanauan de Tuguegarao River*, hence, it is but fitting and proper to name the city road as *Pinacanauan Na Tuguegarao Avenue* which by virtue of this Ordinance shall be its official name.

WHEREFORE, be it ordained by the Seventh City Council in session assembled, to enact:

SECTION 1. TITLE. – This Ordinance shall be referred to as “*An Ordinance Naming the Street from the End of Batang Street, Caggay to the Road Opposite of or Before Lamud Street, Cataggaman Nuevo as Pinacanauan Na Tuguegarao Avenue.*”

SECTION 2. DEFINITION OF TERMS

- a. Avenue – refers to a wide street; a path or driveway that leads to a house located off a main road.
- b. DENR – refers to the Department of Environment and Natural Resources.
- c. Pinacanauan River – refers to the body of water which traverses Barangay Larion Alto, Larion Bao, Capatan, Caggay, Tanza, Centro 09, Centro 10 and Cataggaman Nuevo of Tuguegarao City.


SECTION 3. SEPARABILITY CLAUSE. If, for any reason, any provision, section or part of this Ordinance is declared not valid by a court of competent jurisdiction, suspended or revoked by competent authority, such judgment or act shall not affect or impair remaining provisions, sections or parts of this Ordinance which shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.


