NOW, THEREFORE, be it ordained by the Seventh City Council in session assembled:

SECTION 1. The patronal fiesta celebration of Tuguegarao City shall be known as "AFI Festival."

SECTION 2. All programs and activities that shall be held in the celebration of "AFI Festival" shall be subject to the approval of the Sangguniang Panlungsod of Tuguegarao City.

SECTION 3. The funding of the conduct of the "AFI Festival" shall be appropriated and authorized in the Annual Budget or Supplemental Budget of Tuguegarao City.

SECTION 4. All disbursements shall be in accordance with prescribed guidelines, subject to the usual accounting and auditing rules and regulations.

SECTION 5. REPEALING CLAUSE. City Ordinances or Resolutions which are inconsistent with the provisions of this City Ordinance are hereby modified or repealed accordingly.

SECTION 6. EFFECTIVITY. This City Ordinance shall take effect immediately upon approval.

On motion of Hon. Raymond P. Guzman and with the abstention of Hon. Maiala Rosario T. Que, **CITY ORDINANCE NO. 37-2017** was **APPROVED** on its Second, Third and Final Reading under suspended rules.
