CITY ORDINANCE NO. 39-2017

ORDINANCE INSTITUTIONALIZING THE CONDUCT OF SENIOR CITIZENS DAY IN TUGUEGARAO CITY AND PROVIDING FUNDS THEREFOR

WHEREAS, it is a declared policy of the state to provide adequate social services and an improved quality of life to all. For the purpose, the state shall adopt an integrated and comprehensive social welfare approach towards total health development giving priority to senior citizens among others;

WHEREAS, among the functions of the Local Government Unit is to develop policies, standards, programs and services for senior citizens relative to social and recreational services such as social interaction with peers, counselling, active participation in sports, recreation and socio-cultural activities and holding of special celebrations in recognition of their contributions in nation building;

WHEREAS, the increasing number of senior citizens particularly in Tuguegarao City with more than sixteen thousand nine hundred (16,900) card holders compels the proper caring of our ageing population, hence, the need to provide adequate social welfare services for the elderly basic sector giving



them feelings of fulfilment and self-esteem while still in their prime of life and tapping them their wealth of experience in all kinds of productive endeavor;

WHEREAS, Section 36 of the Local Government Code (RA 7169) mandates Local Government Units to provide assistance, financial or otherwise, to people and non-government organizations, for economic, socially-oriented, environmental or cultural projects for implementation within its territorial jurisdiction;

WHEREAS, the conduct of Senior Citizens Day will provide opportunities where the senior citizens can participate in economic and social development activities in the City and ensure their participation in local governance.

NOW, THEREFORE, be it ordained by the Seventh City Council in session assembled:

SECTION 1. There shall be declared a Senior Citizens Day every year within Tuguegarao City.

SECTION 2. The Senior Citizens Day shall be held every first Saturday of October of the year.

SECTION 3. The Office of the Senior Citizens Affairs (OSCA) in coordination with the City Social Welfare and Development Office (CSWDO), the City Budget Office (CBO), the General Services Office (GSO) and the City Health Office (CHO) shall provide technical assistance and resource augmentation in the conduct of the Senior Citizens Day.

SECTION 4. All City Federation of Senior Citizens Association (FSCA) Officers as well as Barangay Senior Citizens Association (BSCA) presidents shall provide the proper information to the senior citizens of Tuguegarao City relative to the services and activities to be undertaken in the Senior Citizens Day.

SECTION 5. APPROPRIATION/FUNDING. The funding for the conduct of the Senior Citizens Day shall be appropriated and authorized in the City Annual Budget or Supplemental Budget.

SECTION 6. ACCOUNTABILITY. That all disbursements shall be in accordance with the prescribed guidelines subject to the usual accounting and auditing rules and regulations.

SECTION 7. REPEALING CLAUSE. City Ordinance or Resolutions which are inconsistent with the provisions of the City Ordinance are hereby modified and repealed accordingly.


SECTION 8. SEPARABILITY CLAUSE. Should any section or provision of this City Ordinance be declared as unconstitutional or invalid, other provisions which are not affected thereby shall continue to be in full force and effect.

SECTION 9. EFFECTIVITY. This City Ordinance shall take effect immediately upon approval.


