**CITY ORDINANCE NO. 46-2017**

**AN ORDINANCE AMENDING CITY ORDINANCE NO. 08-2013, OTHERWISE KNOWN AS THE "TUGUEGARAO CITY TRICYCLE ORDINANCE 2013"**

Sponsored by: **Hon. Anthony C. Tuddao**

**WHEREAS**, the Sangguniang Panlungsod shall enact ordinances granting franchises upon such condition and for such purposes intended to promote the general welfare of the city and its inhabitants, pursuant to Paragraph 3, Subparagraph VI under Section 458 of the Local Government Code which states that:

(vi) Subject to the guidelines prescribed by the Department of Transportation and Communications, (the Sangguniang Panlungsod shall) regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction;

**WHEREAS**, Tuguegarao City as part of the Metro Tuguegarao PIESTTA Air Shed Board, created by DENR Administrative Order No. 05, Series of 2004, pursuant to Section 9 of R.A. No. 8479 or the Philippine Clean Air Act of 1999, is committed to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

**WHEREAS**, there is a need to amend the definition of "Tricycle" under Section 4 of City Ordinance No. 08-2013, otherwise known as the "Tuguegarao City Tricycle Ordinance 2013" to cover all three-wheeled motorized vehicles.

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod of Tuguegarao City in session assembled, to enact the following:

**SECTION 1. TITLE.** This Ordinance shall be known as the “*Ordinance Amending Section 4(i) of City Ordinance No. 08-2013, Otherwise Known as the Tuguegarao City Tricycle Ordinance 2013.*”

**SECTION 2.** Section 4(i) of Tuguegarao City Tricycle Ordinance 2013 is hereby amended as follows:

- (i) Tricycle – Any three-wheeled motorized vehicle whether fixed or fitted with a sidecar used to convey or transport passengers to their destination

**SECTION 3. REPEALING CLAUSE.** Any Ordinance, Resolutions, rules and regulations or parts thereof which are inconsistent with this Ordinance are hereby repealed accordingly.

**SECTION 4. EFFECTIVITY.** This City Ordinance shall take effect immediately upon approval.


On motion of Hon. Anthony C. Tuddao and without any objection, **CITY ORDINANCE NO. 46-2017** was **APPROVED** on its Third and Final Reading under suspended rules.
