**CITY ORDINANCE NO. 61-2017**

**ORDINANCE AUTHORIZING THE CONDUCT OF NIGHT MARKET ON EXPERIMENTAL BASIS ALONG BONIFACIO STREET (CORNER LUNA STREET TO CORNER ARELLANO STREET) FROM DECEMBER 01, 2017 TO JANUARY 15, 2018**

**WHEREAS**, it is permissible under the Local Government Code that a city, municipality or barangay, through an ordinance, may temporarily close and regulate the use of any local street, road, thoroughfare or any other public place where flea or night market may be established and where goods, merchandise, foodstuffs, commodities or articles of commerce may be sold and dispensed to the general public;

**WHEREAS**, the proliferation of illegal vendors in all corners of the city and in any available spaces in the City Central Market is one of the major problems the Tuguegarao City Government is facing;

**WHEREAS**, the City is very concerned with the plight of these small businessmen and illegal vendors, but there is a need to keep all public places clean with unobstructed flow of traffic and free from crimes;

**WHEREAS**, local residents and visitors feel the need to buy their necessities after working hours up to the late evenings as is being done in urban cities for the convenience of the consuming public and at the same time giving opportunity for these businessmen to sell their wares especially this Christmas Season;

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod of Tuguegarao City in session assembled to enact the following:

**SECTION I.** It is hereby authorized the conduct of night market on an experimental basis along Bonifacio Street.

**SECTION II.** It is hereby authorized the use of part of Bonifacio Street (Corner Luna Street to Corner Arellano Street) for the conduct of the night market from December 01, 2017 to January 15, 2018 at 7:00 PM to 2:00 AM.

**SECTION III.** The Business Permits and Licensing Office (BPLO) under the Office of the City Mayor is hereby tasked to control and supervise the activities in the area.

**SECTION IV.** Only bonafide residents of Tuguegarao City shall be allowed to sell in the area who are to be charged the duly prescribed amount for business permit fees or special permit fees by the Office of the City Treasurer in accordance with the provisions of the Local Revenue Code of Tuguegarao City.

**SECTION V.** The stalls to be put up in the area shall measure 2 meters x 3 meters.

**SECTION VI.** No vendor shall be allowed to transfer or lease any stall assigned to him or her for purposes of gain.

**SECTION VII.** There should be no installation of permanent structures in order that, before and after the operation, the place can be made very clean and free from any garbage and other obstructions to traffic and pedestrians.

**SECTION VIII.** The authorized products to be sold in the "night market" are limited to woven handicrafts, communication gadgets, RTWs, artifacts, gift items, indigenous products, dry goods, preserved goods, and other tourist items but not cooked food, hardware, wet items, liquor, LPG or any combustible materials and any prohibited items.


**SECTION IX.** The Public Safety and Security Office (PSSO), Philippine National Police (PNP) Tuguegarao Station, Bureau of Fire Protection (BFP) Tuguegarao Station and the barangay tanods concerned are hereby tasked to maintain peace and order during the entire duration of the "night market."

**SECTION X.** This Ordinance shall take effect immediately upon approval.


On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Jude T. Bayona and with the objection of Hon. Maila Rosario T. Que, **CITY ORDINANCE NO. 61-2017** was **APPROVED** on its First, Second, Third and Final Reading under suspended rules.
