CITY ORDINANCE NO. 62-2017

ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE CITY OF TUGUEGARAO IN THE AMOUNT OF ONE HUNDRED TWENTY MILLION PESOS (P120,000,000.00) TO FUND THE CONSTRUCTION OF SCHOOL BUILDINGS/CLASSROOMS AND PURCHASE OF FOUR (4) GARBAGE COMPACTORS

BE IT ENACTED, as it is hereby ENACTED, by the Sangguniang Panlungsod of Tuguegarao City, in session assembled that:

SECTION 1. Whereas, City Resolution No. 248-2017 enacted by the Seventh City Council on August 22, 2017 and prior Legislative Authority relative thereto which authorized the availment of the loan borrowing and concomitant legislative authority in pursuit thereof and that this ordinance will strengthen the same as a policy, rule, and requirement of the Bank as pre-requisite for the release of the Loan and as post requirement of the Monetary Board, Central Bank of the Philippines.

SECTION 2. The City Mayor, in representation of the City, hereinafter referred to as the "City", is hereby authorized to enter into a loan contract with the Development Bank of the Philippines, in accordance with Section 297 of Republic Act No. 7160 or the Local Government Code, in the amount of ONE HUNDRED TWENTY MILLION PESOS (P120,000,000.00) under the terms and conditions herein set forth and such other terms and conditions as may be agreed upon with any person, corporation or entity for the purpose of funding priority project/s, and subject to the requirements under Section 123 of Republic Act No. 7653 as implemented by the Bangko Sentral Ng Pilipinas Circular No. 402. In this connection, the City Mayor shall have full power and authority to represent the City in negotiating the terms and conditions for the said borrowing and signing, executing and delivering such agreements, contracts, deeds, papers and documents as may be necessary and proper for the full and total implementation of the authority herein granted;

SECTION 3. The said priority project/s herein specified as the CONSTRUCTION OF SCHOOL BUILDINGS/CLASSROOMS AND PURCHASE OF FOUR (4) GARBAGE COMPACTORS is/are

hereby certified to be a local infrastructure and/or other socioeconomic development projects in accordance with the approved local development plan and public investment program for the current year 2017 of the City of Tuguegarao is supported by a final feasibility study prepared by LGU Tuguegarao which has been approved under the Sangguniang Panlungsod Resolution No. 210-2016 dated November 15, 2016.

SECTION 4. Consistent with the covering Term Loan Agreements, deeds and assignment, mortgage contracts, and such other agreements maybe entered into by the City in connection with the borrowing, the features, terms and conditions shall be as follows and hereby approved:

4.1 Project Name: CONSTRUCTION OF SCHOOL BUILDINGS/CLASSROOMS AND PURCHASE OF FOUR (4) GARBAGE COMPACTORS

SECTION 5. This Ordinance includes ratification of any and all subsequent requests by the City for modification/ revision and/or amendment to be made on the said priority project/s as well as on its approved terms and conditions, and which makes the loan a statutory obligation of the City, including the following:

5.1 The City to execute the loan agreement, promissory notes, and other documents relating thereto, and specifically stating that the loan obligation of the City thereunder, as well as the terms and conditions thereof, shall be valid and binding on the City and shall not be subject to recall by the Sangguniang Panlungsod for the whole term of the loan, regardless of any change in its composition.

SECTION 6. The City hereby appropriates the entire proceeds of the borrowing exclusively to finance the construction of school buildings/classrooms, four (4) garbage compactors and other financial obligations relative thereto. The same shall be embodied in an Appropriation Ordinance to be enacted by the Seventh City Council.

SECTION 7. Any ordinance or parts thereof inconsistent with this enactment are hereby repealed or amended accordingly.

SECTION 8. This Ordinance shall take effect upon its compliance with all procedures required under Republic Act No. 7160 of an Ordinance for its validity, including the affixation of signatures of the /

Sangguniang Panlungsod members in concurrence thereto, composing at least a majority thereof, out of the total of 12 members, on all the pages of this ordinance.

SECTION 9. Effectivity. This Ordinance shall take effect immediately upon approval.
