CITY ORDINANCE NO. 66-2017

CITY ORDINANCE AMENDING SECTIONS 3 AND 8 OF CITY ORDINANCE NO. 41-2017, OTHERWISE KNOWN AS “ORDINANCE REGULATING THE SALE, DISTRIBUTION, POSSESSION AND USE OF FIRECRACKERS, PYROTECHNIC DEVICES AND OTHER SIMILAR EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF TUGUEGARAO CITY”

WHEREAS, Executive Order No. 28 titled “*Providing for the Regulation and Control of the Use of Firecrackers and Other Pyrotechnic Devices*” was issued by President Rodrigo Roa Duterte to provide stricter national standards, rules and regulations regarding the use of firecrackers and pyrotechnic devices;

WHEREAS, City Ordinance No. 41-2017, otherwise known as “*Ordinance Regulating the Sale, Distribution, Possession and Use of Firecrackers, Pyrotechnic Devices and Other Similar Explosives Within the Territorial Jurisdiction of Tuguegarao City*”, was enacted on September 12, 2017 before the guidelines of Executive Order 28 was issued;

WHEREAS, there is a need to amend City Ordinance No. 41-2017 to be consistent with Executive Order No. 28;

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of Tuguegarao in session assembled, to enact the following:

SECTION 1. TITLE. This Ordinance shall be known as “*City Ordinance Amending Sections 3 and 8 of City Ordinance No. 41-2017, Otherwise Known as “Ordinance Regulating the Sale, Distribution, Possession and Use of Firecrackers, Pyrotechnic Devices and Other Similar Explosives Within the Territorial Jurisdiction of Tuguegarao City”*”.

SECTION 2. First Paragraph of SECTION 3 of City Ordinance No. 41-2017 is hereby amended to read as follows:

SECTION 3. TYPES OF FIRECRACKERS AND PYROTECHNIC DEVICES ALLOWED IN THIS ACT. The following common types of firecrackers and pyrotechnic devices may be manufactured, sold, distributed and used, subject to the updated list of prohibited firecrackers and pyrotechnic devices to be issued by the Philippine National Police (PNP).

SECTION 3. Second Paragraph of SECTION 8 of City Ordinance No. 41-2017 is hereby amended to include:

- i. The conduct of firework display shall be under the supervision of a trained person duly licensed by the Philippine National Police (PNP).


SECTION 4. REPEALING CLAUSE. All ordinances, rules and regulations in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.
