CITY ORDINANCE NO. 69-2017

AN ORDINANCE RENAMING DON DOMINGO MARKET AS TUGUEGARAO CITY PUBLIC MARKET (DON DOMINGO)

WHEREAS, Section 13 of Republic Act 7160 of the Local Government Code of 1991 vests the Sangguniang Panlungsod with the power to name or change the name of local government units, public places, streets and structures within their jurisdictions;

WHEREAS, the Don Domingo Market is being rented and used by traders not only from the City but even from nearby towns;

WHEREAS, the Don Domingo Market is being patronized by the residents of the City as well as those from nearby towns;

WHEREAS, the said Market has evolved into a public market catering to vast traders and buyers;

WHEREAS, the Tuguegarao City Government deemed it necessary and convenient to rename the Don Domingo Market to Tuguegarao City Public Market for it to be identified as a public market.

NOW, THEREFORE, be it ordained by the Seventh City Council in session assembled, to enact:

SECTION 1. TITLE. This Ordinance shall be known as "An Ordinance Renaming Don Domingo Market as Tuguegarao City Public Market (Don Domingo)."

SECTION 2. LOCATION. The Tuguegarao City Public Market is located along Balzain East, Tuguegarao City. It is classified as Commercial District 1 (C-1) under the Approved Comprehensive Land Use Plan and Zoning Ordinance CY 2001-2005 under Zoning Ordinance No. 04 dated October 11, 2002 ratified by the Sangguniang Panlalawigan through SP Resolution No. 080-2003 dated March 7, 2003.

SECTION 3. The Don Domingo Market described in Section 2 hereof is hereby renamed and shall henceforth be as it is hereby named TUGUEGARAO CITY PUBLIC MARKET (DON DOMINGO).

SECTION 4. For all Rules, Regulations, Administration, Maintenance and Operation of the Tuguegarao City Commercial Center, the Existing Market Ordinance of Tuguegarao City shall govern and apply until such time that an ordinance shall be enacted for this purpose or the Market Code shall be amended.

SECTION 5. REPEALING CLAUSE. All ordinances or resolutions which are inconsistent with the provisions of this ordinance are hereby repealed.

SECTION 6. SEPARABILITY CLAUSE. Should any section or provision of this City Ordinance be declared as unconstitutional or invalid, other provisions which are not affected thereby shall continue to be in full force and effect.

SECTION 7. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
