CITY RESOLUTION NO. 01-2017

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF EDUCATION (DepEd) NATIONAL FOR THE ABOT ALAM PROGRAM

WHEREAS, the 1987 Constitution, Article XIV, Section 2, Paragraph 4, mandates the State to encourage non-formal, informal and indigenous learning systems as well as self-learning, independent and out-of-school study programs particularly those that respond to community needs;

WHEREAS, to realize the above mandate, the Local Government Unit (LGU) of Tuguegarao City maintains non-formal education programs to cater to its out-of-school youth;

WHEREAS, the Department of Education (DepEd) is implementing the Abot Alam Alternative Learning Program in support to the mandate of the Constitution to offer education to out-of-school youth;

WHEREAS, DepEd National intends to grant the amount of One Million and Five Hundred Thousand Pesos (P1,500,000.00) from the funds of the Abot Alam Program to LGUs with outstanding accomplishments on Literacy Program to be used by the latter to implement and improve their literacy programs and projects;

WHEREAS, LGU Tuguegarao City is one of the identified recipients of the said funds from DepEd National;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested from the Seventh City Council an authority to sign the Memorandum of Agreement (MOA) for the release of the herein stated funds;

WHEREAS, after a perusal of the MOA during the Special Session held on January 05, 2017, the Seventh City Council found the MOA to be in order and the Abot Alam Program to be beneficial to the constituents of the City more so to the out-of-school youth.

NOW, THEREFORE, RESOLVED, as it is RESOLVED, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Education National for the Abot Alam Program.


RESOLVED FURTHER, to forward a copy of this resolution to the Department of Education National for appropriate action.
