CITY RESOLUTION NO. 002-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT THE PERFORMANCE COMMITMENT WITH PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) WITH SPECIFIC PROVISIONS FOR PRIMARY CARE BENEFIT PROVIDERS (PC FOR PCB1/MATERNAL AND CHILD PACKAGE/TB DOTS

WHEREAS, the Local Government Code of 1991 mandates the devolution of health services from the Department of Health (DOH) to local government units (LGUs);

WHEREAS, the Local Government Unit of Tuguegarao City actualizes this mandate by entering into a performance commitment with Philhealth which is a government-owned corporation created to implement universal health coverage;

WHEREAS, with the above premise, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the performance commitment of Tuguegarao City prepared by the City Health Office;

WHEREAS, in the said endorsement, the City Mayor asked for an authority to sign for and behalf of the City Government the said performance commitment;

WHEREAS, after a perusal and discussion on the personal commitment, the Seventh City Council during their 22nd Regular Session found the same to be in order and beneficial to the constituents of Tuguegarao City.



Soriano, to sign for and on behalf of the City Government the performance commitment with Philippine Health Insurance Corporation (PHILHEALTH) with specific provisions for primary care benefit providers (PC for PCB1/Maternal and Child Package/TB Dots.
