CITY RESOLUTION NO. 004-2017

RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO ENTER FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT INTO A COLLECTION AND REMITTANCE AGREEMENT WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) FOR THE COLLECTION OF PHILHEALTH PREMIUM CONTRIBUTIONS

WHEREAS, the National Health Insurance Program (NHIP) was established in February 1995 pursuant to the National Health Insurance Act of 1995 to provide all citizens of the Philippines with a mechanism to gain financial access to health services;

WHEREAS, to achieve this objective, PhilHealth must establish and maintain an efficient premium collection mechanism, and thus, it needs to engage the services of accredited collecting agents to enable its members to pay their premium contributions;

WHEREAS, for convenience, accessibility and proximity of the paying public, PhilHealth includes the Local Government Units in the list of eligible entities which may be accredited as collecting agents for premium contributions;

WHEREAS, the Local Government Unit of Tuguegarao City is willing to act as PhilHealth collecting agent for all its paying members except OFWs;

WHEREAS, as an accredited Collecting Agent of PhilHealth (ACA), LGU Tuguegarao City agreed to abide by the accreditation warranties and standards as prescribed in PhilHealth Circular No. 08, s-2009 or the New Guidelines for Accrediting Collecting Agents for the Collection of PhilHealth Premium Contributions.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to enter for and on behalf of the Tuguegarao City Government into a collection and remittance agreement with the Philippine Health Insurance Corporation (PhilHealth) for the collection of PhilHealth premium contributions.


