

RESOLVED FURTHER, that a copy of this Resolution be forwarded to Mr. Pulliante, for his information.


On motion of Hon. Jude T. Bayona and without any objection, **CITY RESOLUTION 005-2017** was **APPROVED** in plenary under suspended rules.
