CITY RESOLUTION NO. 008-2017

A RESOLUTION RECOMMENDING THE RECLASSIFICATION/CONVERSION OF AGUINALDO EXTENSION, STARTING FROM CORNER VALENZUELA STREET TO CAPATAN-LIBAG ROAD, FROM A CITY ROAD TO NATIONAL ROAD

WHEREAS, under Executive Order No. 124, series of 1987, the Department of Public Works and Highways (DPWH) is mandated to *"provide or authorize the conversion of roads"*;

WHEREAS, the reclassification/conversion of Aguinaldo Extension, starting from corner Valenzuela Street to Capatan-Libag Road would vest jurisdiction to DPWH so that it can finance and undertake the construction and maintenance of said road;

WHEREAS, the conversion of any local road requires a resolution from the City Council;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested for a resolution from the Seventh City Council for the herein purpose;

WHEREAS, after a discussion on the request during their 24th Regular Session, the Seventh City Council find the same to be in order and beneficial to the constituents of Tuguegarao City.


