CITY RESOLUTION NO. 008-2017

A RESOLUTION RECOMMENDING THE RECLASSIFICATION/CONVERSION OF AGUINALDO EXTENSION, STARTING FROM CORNER VALENZUELA STREET TO CAPATAN-LIBAG ROAD, FROM A CITY ROAD TO NATIONAL ROAD

WHEREAS, under Executive Order No. 124, series of 1987, the Department of Public Works and Highways (DPWH) is mandated to "provide or authorize the conversion of roads";

WHEREAS, the reclassification/conversion of Aguinaldo Extension, starting from corner Valenzuela Street to Capatan-Libag Road would vest jurisdiction to DPWH so that it can finance and undertake the construction and maintenance of said road;

WHEREAS, the conversion of any local road requires a resolution from the City Council;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested for a resolution from the Seventh City Council for the herein purpose;

WHEREAS, after a discussion on the request during their 24th Regular Session, the Seventh City Council find the same to be in order and beneficial to the constituents of Tuguegarao City.

NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to recommend the reclassification/conversion of Aguinaldo Extension, starting from corner Valenzuela Street to Capatan-Libag Road, a City Road to a National Road.

RESOLVED FURTHER, that a copy of this resolution be forwarded to the Department of Public Works and Highways (DPWH) Regional Field Office No. 02, for proper action.
