CITY RESOLUTION NO. 031-2017

RESOLUTION GRANTING AUTHORITY TO THE TUGUEGARAO CITY FRANCHISING BOARD TO AUTHORIZE MR. DOMINGO S. DE GUZMAN TO APPLY FOR A CHANGE OF UNIT OF HIS TRICYCLE FOR HIRE SUBJECT TO COMPLIANCE WITH THE REQUIREMENTS AS PROVIDED IN CITY ORDINANCE NO. 08-2013 AND THE PAYMENT OF REQUISITE FEES

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the request of Mr. Domingo S. De Guzman for a Change of Unit and Renewal of Franchise of his carnapped tricycle for hire for proper action;

WHEREAS, attached to the endorsement is the Tuguegarao City Franchising Board's provisional authority to Mr. Domingo S. De Guzman to operate tricycle for hire with Case No. 98-6890;

WHEREAS, after the joint Committee on Transportation and Committee on Rules, Laws and Ethics deliberated on the matter, the committees found the request for Change of Unit to be proper and meritorious considering that this was supported by a Police Report and Affidavit of Loss;

WHEREAS, his application for a Renewal of Franchise shall only be acted upon by the committees upon replacement of his lost tricycle with a new tricycle unit on or before February 28, 2017.


NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to grant authority to the Tuguegarao City Franchising Board to authorize Mr. Domingo S. De Guzman to apply for a Change of Unit of his tricycle for hire subject to compliance with the requirements set forth in City Ordinance No. 08-2013 and the payment of requisite fees on or before February 28, 2017.

RESOLVED FURTHER, to furnish copies of this resolution to Mr. Domingo S. De Guzman, the Tuguegarao City Franchising Board and the City Mayor, Hon. Atty. Jefferson P. Soriano, for their information and appropriate action.
