**CITY RESOLUTION NO. 046-2017**

**RESOLUTION APPROVING BARANGAY ORDINANCE NO. 7 SERIES OF 2016 OF BARANGAY NAMABBALAN SUR TITLED AN ORDINANCE IMPOSING FEE ON THE IMPLEMENTATION OF KATARUNGANG PAMBARANGAY**

**WHEREAS**, Barangay Namabbalan Sur has submitted to the Seventh City Council for review Barangay Ordinance No. 7-2016 “An Ordinance Imposing Fee on the Implementation of Katarungang Pambarangay”;

**WHEREAS**, the Joint Committee on Barangay Affairs and Committee on Rules, Laws and Ethics, to which the matter was referred, reviewed and deliberated on the imposition of fees on the implementation of Katarungang Pambarangay;

**WHEREAS**, Section 410 of Local Government Code of 1991 provides the procedure for amicable settlement: (a) Who may initiate proceeding – Upon payment of the appropriate filing fee, any individual who has a cause of action against another individual involving any matter within the authority of the lupon may complain, orally or in writing, to the lupon chairman of the barangay;

**WHEREAS**, upon review of the said Barangay Ordinance, the joint committees recommended for the inclusion of the provision that 50% of the collections will be used to sustain the operations of the Katarungang Pambarangay.






