WHEREAS, under Chapter 2, Section 17, of Local Government Code, it is the obligation of the Local Government Unit to provide services to the barangays;

WHEREAS, one of the biggest concerns when it comes to the use of technology in schools or in the community is how easy pornographic, violent, and other inappropriate materials can be accessed and viewed;

WHEREAS, technology hinders children's ability to think for themselves and to learn through the old methods of research;

WHEREAS, reading books are now seldom used since children are indulging much time on gadgets and/or computers;

WHEREAS, one method to boost children's learning potential is by making books an integral part of their lives;

WHEREAS, there shall be a reading activity for 30-45 minutes in Ibanag, Itawes and Ilocano among Day Care Pupils at the Day Care Centers during Barangay People's Day and every Fridays of the month except holidays and semestral break;

WHEREAS, the said activity shall be facilitated by the City Librarian with the assistance of the Day Care Teachers and Parents;

WHEREAS, the City Librarian shall provide the mechanics of the storytelling activity and the reading materials as part of the programs and/or projects of the City Library;

WHEREAS, there are sufficient reading materials available in the City Library to be used during the said reading activity;

WHEREAS, the City Librarian shall coordinate with the City Social Welfare and Development Officer and the Parents-Teachers Associations at the Barangay Day Care Centers within Tuguegarao City in the implementation of the reading activity among Day Care Pupils.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the conduct of a reading activity in Ibanag, Itawes and Ilocano among day care pupils at the Day Care Centers within Tuguegarao City during Barangay People's Day and every Fridays of the month except holidays and semestral break.

RESOLVE FURTHER, that a copy of this resolution be forwarded to the Office of the City Mayor, Hon. Atty. Jefferson P. Soriano, for information and appropriate action.

On joint motion, **CITY RESOLUTION NO. 047-2017** was **APPROVED** in plenary under suspended rules.




