**CITY RESOLUTION NO. 050-2017**

**A RESOLUTION GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, THE CITY MAYOR, AND/OR ACTING CITY MAYOR, TO SIGN FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT (LGU) OF TUGUEGARAO CITY THE MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL MEAT INSPECTION SERVICE (NMIS) – DEPARTMENT OF AGRICULTURE (DA) FOR THE IMPLEMENTATION OF A SMALL SCALE MEAT ESTABLISHMENT (POULTRY – DRESSING PLANT)**

**WHEREAS**, Republic Act 9296 as amended by Republic Act 10536, otherwise known as the Meat Inspection Code of the Philippines, provides that Local Government Units (LGUs) shall endeavor to improve existing meat facilities to comply with the national standards, and the national government shall allocate funds as incentive, equivalent to the funds available from LGUs for this purpose;

**WHEREAS**, the Meat Inspection Improvement Program (MEIP) is designed to assist LGUs to rehabilitate and/or complete their existing slaughterhouses and poultry dressing plants to comply with Class “AA” requirements under National Meat Inspection Service (NMIS) accreditation system;

**WHEREAS**, the National Meat Inspection Service (NMIS) grants financial assistance to qualified LGUs through the Meat Establishment Improvement Program (MEIP);

**WHEREAS**, the Local Government Unit of Tuguegarao City in its quest to continuously improve its slaughterhouse for better service to its constituents, desires to avail of the Meat Establishment Improvement Program (MEIP);

**WHEREAS**, after an exhaustive discussion during the Special Session called for the purpose, the Seventh City Council found the necessity of passing a resolution as stated herein;

**WHEREAS**, City Resolution No. 134-2016, dated August 23, 2016 is hereby revoked.


**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to grant authority to the Local Chief Executive, the City Mayor, and/or Acting City Mayor, to sign for and on behalf of the Local Government Unit (LGU) of Tuguegarao City the Memorandum of Agreement (MOA) with the National Meat Inspection Service (NMIS) – Department of Agriculture (DA) for the implementation of a Small Scale Meat Establishment (Poultry – Dressing Plant) subject to the submission of the said MOA to the Seventh City Council for final consideration and ratification of the same.

**RESOLVE FURTHER**, to forward a copy of this Resolution to the National Meat Inspection Service (NMIS) – Department of Agriculture (DA), for information and appropriate action.


On joint motion, **CITY RESOLUTION NO. 050-2017** was **UNANIMOUSLY APPROVED** in plenary under suspended rules.


