**CITY RESOLUTION NO. 063-2017**

**A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 020, SERIES OF 2016 OF BARANGAY TANZA TITLED “AN ORDINANCE REGULATING STRAY DOGS IN BARANGAY TANZA IN ADDITION TO NATIONAL LAWS SUCH AS THE ANTI-RABIES ACT OF 2008 AND THE ANIMAL WELFARE ACT OF 1998, PRESCRIBING RULES AND GUIDELINES FOR THEIR PROPER CARE AND KEEPING AND PROVIDING PENALTIES FOR VIOLATION THEREOF”**

**WHEREAS**, Barangay Tanza has submitted to the Seventh City Council for review Barangay Ordinance No. 020, series of 2016 titled “*An Ordinance Regulating Stray Dogs in Barangay Tanza in Addition to National Laws such as the Anti-Rabies Act of 2008 and the Animal Welfare Act of 1998, Prescribing Rules and Guidelines for their Proper Care and Keeping and Providing Penalties for Violation Thereof*”;

**WHEREAS**, the Committees initially met on August 30, 2016 to discuss the subject referral and recommended for the return of the ordinance, subject for modification and refinement with the advice to the Barangay Officials to coordinate with the City Veterinary Office and with the Liga ng mga Barangay and City Legal Office regarding the improvement of the ordinance;

**WHEREAS**, the Barangay Council of Tanza resubmitted the modified ordinance for its final approval which was discussed during the Committee Meeting scheduled on February 06, 2017;

**WHEREAS**, the joint Committee on Rules, Laws and Ethics, Committee on Barangay Affairs and Committee on Public Safety and Order and Disaster Preparedness found the Barangay Ordinance to be in order and to have complied with all the requirements set forth by law in form, substance and scope;

**WHEREAS**, upon review of the said Barangay Ordinance, the joint committees approved the same since it is beneficial to the constituents of the barangay.

**NOW, THEREFORE, RESOLVED**, as it is hereby **RESOLVED**, to approve Barangay Ordinance No. 019, series of 2016 of Barangay Tanza titled “*An Ordinance Regulating Stray Dogs in*
